Simple DIY Set Up

Compatibility Requirements



STEP 1 Press any button on the control to initiate set up. LED indicator light will blink until app set up is complete.



STEP 2 Download the Cync App, powered by Savant.



STEP 3 Add your Wire-Free Smart Remote to the Cync App.



STEP 4 Add your Wire-Free Smart Remote and Cync or C by GE Smart devices you want to control to the same Room or Group in app.

What You Can Do With Your Wire-Free Smart Remote



Wire-Free Smart Remote + Smart Bulb

- · Turn off lights from bed
- · Dim the lights for movie time
- Change the light color to a warm, amber light in the evening and to a cool, vibrant light in the morning*



Wire-Free Smart Remote + Smart Plug


- · Control devices like fans and space heaters across the room
- · Turn on lights when entering a room
- Remotely control lamps with integrated LEDs or nonstandard bulbs



Wire-Free Smart Remote + Smart Switch

- · Stick the remote on a metal door frame and create a wireless 3-way connection
- · Set up a master on/off switch next to your bed

Removing/Replacing the Battery

Uses One CR2032 Coin Battery

STEP 1

Remove rear housing of the Wire-Free Smart Remote by inserting a flat head screwdriver into the part at the bottom of the remote.

STEP 2


Slide the battery out, toward the top of the Wire-Free Smart Remote.

STEP 3

Slide a new battery underneath the contact strap, with the (+) terminal toward the back of the Wire-Free Smart Remote.

STEP 4

Replace rear housing.
